POLICIES:

5. Piñatas or helium balloons cannot be accommodated unless balloons are secured/weighted.
6. Parents may observe and are welcome to take pictures.
7. Group activities are held on the main floor and food/drink held in Studio A.
8. Alcoholic beverages are prohibited.
9. Birthday themed plates, napkins, tablecloths and utensils are provided.
10. Pizza will be ordered using the confirmed # of participants (children only)
11. One Martial Arts agrees to provide the service stated within this agreement.
12. One Martial Arts will not cancel or forfeit this agreement without proof of a legitimate condition beyond our control. In any event, One Martial Arts would only be liable to the purchaser for the deposit as stated.
13. OVERTIME POLICY: If purchaser exceeds "end time", overtime fees will be due to One Martial Arts. The fees are due at the commencement of overtime (\$49 per 1/2 hour).
14. END EARLY POLICY: Should the event end early, other than by part of One Martial Arts, the said purchaser is still liable to One Martial Arts for the total fee as stated in this agreement.
